OUR HOUSING PROGRAM PROVIDES FAMILIES WITH A WIDE RANGE OF HOUSING SOLUTIONS, INCLUDING HOMELESS PREVENTION SERVICES, EMERGENCY MOTEL STAYS, INTERIM HOUSING, RAPID REHOUSING, RENTAL ASSISTANCE, AND AFFORDABLE HOUSING OPPORTUNITIES.
